**SCOTTISH TRUNK ROAD NETWORK MANAGEMENT CONTRACT – SOUTH EAST UNIT
A68 LAUDER HIGH STREET – CARRIAGEWAY INVESTIGATION WORKS**

BEAR Scotland, acting on behalf of Transport Scotland, are planning to carry out carriageway investigation works on the A68 trunk road across Lauder High Street. Please see the enclosed location plan for further details of the extents.

The investigation works will comprise of digital surveys and the extraction of core samples of the road which will help to guide the future carriageway improvements in the area.

The works have been provisionally programmed over 3 shifts on Wednesday 11th, Thursday 12th and Monday 23rd June between the hours of 17:00 and 22:00 each night. The works have been planned to take place during daylight hours whilst avoiding disruption to road users and local residents over the main part of the day.

During this period the road will remain open, however mobile Stop/Go traffic management will be in place to ensure the safety of both road users and site operatives. Please see the programme summary below.

	Wednesday 11 th – Thursday 12 th June 2025	17:00 – 22:00	<u>Wednesday 11th June</u> Works will begin in the northbound lane at the South Market Place junction (Mid Row) and will progressively move north. <u>Thursday 12th June</u> Works will begin in the southbound lane from the Whitlaw Road Industrial Estate (junction north of Co-op) and will progressively move south.
	Monday 23 rd June	17:00 – 22:00	Lane closure with mobile Stop/Go traffic management setup across the site extents in place for coring extraction works.

Works have also been planned with mobile Stop/Go traffic management to minimise disruption to road users and local communities by reducing the number of shifts required, however there will be a limited impact on journey times. Access for emergency vehicles will be maintained at all times and all traffic management will be removed out with working hours. There may be some limited noise disruption during the pavement coring works on Monday 23rd June, however these will be completed by 22:00hrs to minimise disruption to local residents.
